PROGRAMS

Since 1997, Step By Step has walked alongside and supported low-income women to help them have healthy babies and get a good start to parenting. Our primary programs are Maternity Support Services and Infant Case Management through home-visitation with licensed nurses, dietitians, and counselors. We serve approximately 900-1,200 women annually throughout Pierce, King, and Snohomish counties. In addition to case management services, we fulfill our mission through the following programs and services:

In 2019, we introduced Farm 12, the start of our social enterprise drivers. Today, we have Farm 12 Restaurant, Farm 12 Events, Fika Coffee, and the Loveland Greenhouse. Through these businesses we provide moms with employment opportunities and 100% of all profits support our mission.

796 welcome home bags and infant care packages distributed.

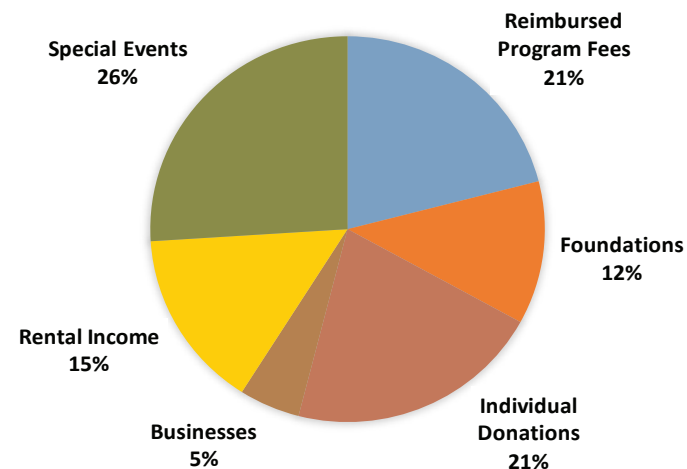


9 moms graduated from our first Dreams Work Job Training cohort.
